Please read all enclosures carefully for any changes and new information.*

*The money collected from registrations and advertising is what pays for publicity, official program books, sanitation, road signs, promotion, entertainment and all other expenses that are associated with this highly successful Fall Festival.*

*All vendors are encouraged to take advantage of the advertising in the Fall Festival program book. Forms are enclosed with cost, ad sizes and deadline of June 1<sup>st</sup>.*

*Again this year we will be collecting recipes for the annual cook book. Anyone can submit a recipe(s). Please send your recipes to the above address by May 1<sup>st</sup>, 2019. Several vendor participants choose to dress in turn of the century attire. This is not required but can be a lot of fun.*

### ***Rules/ regulations for all Spoon River Valley Scenic Drive Associates Fall Festival participants:***

- 1. Fall Festival dates are always the first two full weekends of October. This year dates are:  
Sat. Oct. 5<sup>th</sup> & Sun. Oct. 6<sup>th</sup> and Sat. Oct. 12<sup>th</sup> & Sun. Oct. 13<sup>th</sup>, 2019 Hours are 9 a.m. – 5 p.m.*
- 2. It is the responsibility of the vendor to contact the area rep. or site manager of area/site wishing to attend.*
- 3. ALL vendors are required to pay the SRVSD Associates registration fees. The fee is the same for one day or all four days. Fees are:  
For Non-Fulton County food vendors fee is \$100 and after Sept. 1<sup>st</sup> fee increases to \$150.  
For all other vendors fee is \$50 and after Sept. 1<sup>st</sup> fee increases to \$75.  
This is in addition to area or site set-up fees that may be required.*
- 4. Each paid vendor will receive a contributor sign, commemorative button, and vendor ribbon, which is to be publicly displayed, showing you are officially registered with the SRVSD Associates.*
- 5. To be listed in the official program book, as a participant at your area/site, **your registration and payment must be received before June. 1<sup>st</sup>, 2019.***
- 6. All food vendors/concessions are required to obtain a temporary food service permit from the Fulton County Health Department. Contact information:

- 7. All food vendors/concessions are required to provide a certificate of product liability insurance, which is to be included with SRVSD Associates registration or registration will be returned.*
- 8. All registration forms, advertising forms, payments and voluntary 10% fees should be sent to:

- 10. Vendors will not sell illegal items.*
- 11. The Spoon River Valley Scenic Drive Associates reserves the right to refuse set up to any vendor that they feel is inappropriate for the Fall Festival.*
