Thank you for your interest in joining us in Bernadotte Public Park for this year's Spoon River Valley Scenic Drive. Please return this application asap to reserve your spot. SRVSD is held rain or shine.

\*Space sizes are 10x15 and are rented for \$65 per weekend OR -

- 1 space both weekends \$100
- 2 spaces both weekends \$200
- 3 spaces both weekends \$275
- 4 spaces both weekends \$360

\* Set Up - spaces will be marked and set up may begin on Friday morning before the first day of the Drive. If no representative is present when you arrive, a map will be posted in the pavilion to help you find your space.

\* All vendors MUST register and pay the Spoon River Valley Scenic Drive Association fee to set up in Bernadotte Public Park. SRVSD Association fees should be mailed separately from Bernadotte Park booth fee.

\* Handmade crafts and antiques are preferred but all vendors will be considered by following guidelines:

1. All vendors and merchandise must stay within allotted space(s) as assigned by the committee. Please rent enough space to adhere to this guideline. The committee reserves the right to assign all space numbers.
2. Please contact us if you should need to cancel. Sorry, no refunds will be issued after September 1st. Subletting must be pre-approved.
3. Vendors are responsible for keeping booth space clean, please keep your area clean throughout the Drive.
4. To avoid ruts and damage to the park grounds, please do not pull into the park to unload without prior permission.
5. No cheap/toy weapons, nuisance items (i.e.. silly string, etc), fireworks, pets/live animals, pornographic or offensive items may be sold or displayed. The committee has the right to refuse to permit inappropriate items to be sold.
6. Direct sell businesses will be limited to one per company, at the discretion of the committee, and accepted on first-come, first-serve basis.
7. Bernadotte Public Park and Associates are not responsible for accidents or loss.
8. Confirmations will be sent via email prior to the show.
